Clinical Psychologist – Psychologists would complete timely psychological evaluations for individuals with developmental disabilities which include: standardized measure of intellectual functioning, standardized measure of adaptive functioning, structured parent interview/rating scale related to Autism Spectrum Disorder (ASD), direct observational measure for ASD, and have the ability to conduct home/school observations.
